No. 37-3/Legal/AICTE/2009 dated July 01, 2009 on "Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting Technical Education" and UGC Regulations, 2009 on curbing the menace of ragging in higher educational institutions, the Anti-Ragging Squads are hereby constituted with effect from 01/09/2025 for a period of about three months, as per the enclosed details and duty schedules.

**1. Duties and Responsibilities of Anti-Ragging Squads**

All Anti-Ragging Squad members shall report at least 5 minutes before duty in the Control Room (Warden's Room), Ground Floor, Boys' Hostel, and make necessary entries in the register kept with the security guard. At the end of each duty slot, the squad must submit a report in the register.

1. Squads shall make surprise inspections in hostels and other vulnerable locations within and around the Institute to prevent incidents of ragging.
2. Squads shall conduct on-the-spot enquiries of ragging incidents reported by the Head of Institution, faculty, staff, students, parents/guardians, service providers, or any person. Reports with recommendations shall be submitted to the Proctor. Enquiries must follow the principles of natural justice, ensuring fairness and adequate opportunity for the accused students and witnesses.
3. In case of any ragging incident, the Squad shall submit a separate report to the Proctor, who will forward it to the Director. A copy will be retained with the Proctor. Leave during duty shall not normally be entertained; in exceptional cases, it will require the approval of the Director.
4. The security guard in the Control Room shall ensure safe custody of all records and promptly inform concerned authorities of any incident or irregularity.
5. Wardens shall maintain strict discipline inside the hostels with the support of squad members and hostel staff.
6. During opening/locking of hostels, wardens shall mark attendance of all inmates. No student shall leave the hostel without prior permission. Unauthorized absence must be reported immediately to the warden.
7. from hostels to classrooms and back.
8. Hostels for newly admitted students shall remain locked from 10:00 PM to 06:00 AM (Boys' Hostel) and 08:00 PM to 06:00 AM (Girls' Hostel).
9. Squads shall take frequent rounds of hostels and other sensitive areas.
10. No honorarium or payment shall be made for this duty.
11. All squad members are requested to treat this duty as top priority to ensure that the academic session remains completely free from ragging incidents.
